We hereby submit specifications and estimates for: Home Service

Complete summerization and winterization of pool at above address for the 2012 swimming season.

- 1. Home service is to be performed once a week for up to 22 weeks. Twice a week service can be contracted for an additional \$750.00.
2. Water analysis. All chemicals necessary to maintain proper water balance will be provided by contractor.
3. Home service maintenance involves: vacuum of pool as needed, backwashing of filter, cleaning of lint basket in pump, maintaining proper water chemistry, cleaning of skimmer baskets and netting pool water surface.
4. It is the responsibility of the home owner to keep the water level raised to the middle of the skimmer.
5. Contractor will perform home service between Thursday-Saturday. Contractor must be able to access site during this time frame or services will not be performed for that service week at the owner's expense.
6. Services will be suspended for failure of mid-summer installment payment. There will be an extra charge, not to exceed \$150.00, for chemicals necessary to repair water quality if service has been suspended and water quality has been affected.
7. Client will be notified of any extra repairs, parts, or equipment needed and will be billed separately.
8. Prior to pool opening it is the customers responsibility to raise water level (mid skimmer) and have cover pumped off, if possible.
